- Object at any time under Art. 21 GDPR to processing of personal data concerning you which is based on Art 6 (1) lit. e or f GDPR, on grounds relating to your particular situation.
- Data portability as defined in Art. 20 GDPR.

Where you have given your consent to the processing of personal data, you can withdraw your consent at any time. Withdrawal of consent will not affect the lawfulness of processing based on consent up to the time of withdrawal of consent.

Processing of personal data

We process personal data that you provide voluntarily, e.g. when you make an inquiry or when you order information material or newsletters. Legal basis in this case is Art. 6 (1) lit. b GDPR. In as far as we process your data as described above for the purpose of accepting and processing your inquiry or (newsletter) order, you are contractually bound to make these data available to us. We are unable to process your request without the data.

Where you have given your consent to the processing of personal data (cf. Art. 6 (1) lit. a GDPR), you can withdraw your consent at any time. Withdrawal of consent will not affect the lawfulness of processing based on consent up to the time of withdrawal of consent.

We process your personal data only for the purposes specified in this data privacy statement. They are not passed on to third parties for any other purpose. We will only pass on your personal data in the following cases:

- You have given us your explicit consent.
- The processing is governed by an agreement or other binding legal instrument.
- The processing is necessary for compliance with a legal obligation.
- The processing is necessary to safeguard justified interests and there is no reason to believe that your legitimate interests for excluding the processing of the data take precedence.

With your consent, we provide you with our LBST newsletter or similar information at irregular intervals by e-mail to your specified e-mail address.

Providing your e-mail address is sufficient for receiving the newsletter. The data entered when registering for the newsletter service will be used only for that purpose. Subscribers may be informed by e-mail about relevant topics relating to the newsletter service or the registration for it (e.g. changes in the service or technical requirements).

You can object to processing your personal data and their use for the newsletter service at any time by sending a note to unsubscribe@lbst.de; any newsletter contains a corresponding link. Alternatively, you may also address your objection to the contact given below at the end of this data privacy statement.
